Your traffic summons requires you to appear in person in court on the date written at the bottom of the ticket; **UNLESS** you wish to plead guilty in writing and pay your fine and costs by mail or in person before your court date.

Only those violations listed on this notice may be paid in advance or by mail. You must appear in court if you were involved in an accident. If your violation is listed and you wish to plead guilty without coming to court, follow these steps:

<u>Offenses</u>	<u>Fine &amp; Costs</u>
<b>SPEEDING:</b>	
1 to 10 mph over speed limit	<b>\$4.00</b> per mile over speed limit + <b>\$32.50</b>
11 to 24 mph over speed limit	<b>\$5.00</b> per mile over speed limit + <b>\$32.50</b>
* Court appearance is required for speeding 25 mph or more over speed limit.	

**VEHICLE LICENSE:\***

Expired license, no license, failure to transfer, failure to title, no trailer license, plates of another person, no front license plate, and no valid inspection. **\$132.50\***

**DRIVER'S LICENSE:\***

Permit unauthorized person to drive. **\$132.50\***

**EQUIPMENT:\***

Defective equipment, tinted windows, no headlights, no taillights, and no light over licensplate. **\$97.50\***

**OTHER VIOLATIONS:**

Stop Sign	<b>\$107.50*</b>
Wrong Way – One-way street	<b>\$107.50*</b>
Passing on the right	<b>\$132.50*</b>

**COURT APPEARANCE IS REQUIRED FOR THE FOLLOWING OFFENSES:**

- Speeding (25 miles or more over limit)
- Careless and Imprudent Driving
- Driving While Intoxicated
- Driving While Under Suspension or Revocation
- Leaving Scene of Accident
- Driving Without a Valid or No License
- Other Traffic Offenses
