

TRAFFIC VIOLATIONS BUREAU INFORMATION

Your traffic summons requires you to appear in person in court on the date written at the top of the ticket; UNLESS you wish to plead guilty in writing and pay your fine and costs by mail, over the phone, or in person before your court date.

Only those violations listed on this notice may be paid in advance. You must appear in court if you were involved in an accident. If your violation is listed and you wish to plead guilty without coming to court, these are your options:

1. Call Weston Municipal Court at 816-640-2752 to make a payment over the phone with a debit or credit card, or direct deposit through a savings or checking account.
2. Sign your name to the waiver on the back of the ticket, and bring or mail your signed ticket and a Personal Check, Money Order, or Cashier's Check.

Make check payable to Weston Municipal Court.

WARNING: A warrant may be issued for your arrest IF you fail to appear in court on your scheduled court date, UNLESS you have paid or requested a continuance. Call the court number below to request a continuance.

SPEEDING:

1 - 5 mph over	\$ 83.00
6 - 10 mph over	\$ 93.00
11 - 15 mph over	\$ 103.00
16 - 19 mph over	\$ 133.00
20 - 25 mph over	\$ 188.00

*Court appearance is required for speeding 25 mph or more over speed limit.

VEHICLE LICENSE:*

Expired license, no license, failure to transfer, failure to title, no trailer license, plates of another person, no front license plate, & no valid inspection. **\$ 83.00**

EQUIPMENT:*

Defective equipment, tinted windows, no headlights, no taillights, & no light over license plate. **\$ 83.00**

OTHER VIOLATIONS:

Passing on the right	\$ 113.00

COURT APPEARANCE IS REQUIRED FOR THE FOLLOWING OFFENSES:

- Speeding (25 miles or more over limit)
- Careless and Imprudent Driving
- Driving While Intoxicated
- Driving While Under Suspension or Revocation
- Leaving Scene of Accident
- Driving Without a Valid or No License
